**Refund Rules:**

If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution concerned shall follow the following four-tier system for the refund of fees remitted by the student.

Sr. No	Percentage of Refund of Aggregate fees*	Point of time when notice of withdrawal of admission is served to HEI	Date
(1)	100%	15 days before the formally-notified last date of admission	On or before 02 <sup>nd</sup> July'2018
(2)	80%	Not more than 15 days after the formally-notified last date of admission	03 <sup>rd</sup> July to 02 <sup>nd</sup> August'2018
(3)	50%	More than 15 days but less than 30 days after formally-notified last date of admission	03 <sup>rd</sup> August to 17 <sup>th</sup> August'2018
(4)	00%	More than 30 days after formally-notified last date of admission	18 <sup>th</sup> August'2018 onwards

**\*(Inclusive of course fees and non-tuition fees but exclusive of caution money and security deposit)**

In case of (1) in the table above, the deduction will be 10% of the aggregate fees as processing charges from the refundable amount. Aggregate fees is inclusive of course fees and non-tuition fees but exclusive of caution money and security deposit.
