1. Introduction:

This booklet gives information about the Admission Procedure of full time M. Pharm. (Two years) / M. Pharm.

+ MBA (Three Years) Program for the academic year 2025-26.

2. Program, Specialization & Intake:

- Each specialization shall commence only if there are a minimum of 10 eligible / admitted candidates after the selection process except for Pharmacology.
- The admission process shall start for M. Pharm + MBA & M.Pharm (Regulatory Affairs) program first. After admission counselling, if seats are vacant in M. Pharm + MBA, then vacant seats shall be allotted to M. Pharm program. This applies for all specializations except Regulatory Affairs

3. Eligibility Criteria: (Fulfillment all / applicable conditions mandatory)

- The candidates who are appearing for final year of B. Pharm examination are eligible to apply.
- Candidate whose final marksheet is not available at the time of admission are required to submit internet / Digi-locker copy of result duly attested by Principal of the college.
- AlU equivalence certificate to confirm the eligibility for the program is mandatory for those candidates who have completed B. Pharm from Overseas University.
- Candidates whose final mark sheet of the qualified examination is not available at the time of their provisional admission, is required to submit their final marksheet copy as soon as the result declared. In such case, if the candidate fail to meet the required eligibility criteria then his / her admission will be cancelled and the fees will be refunded as per NMIMS refund rules (even after course commencement).

- The Graduation (Qualified) examination should have been conducted before the course commencement date.
- Mark sheet / Transcripts issued by Board / University shall be considered (School / Institute will not be accepted).
- Internal / Stream Transfer will be entertained only through upgradation process.
- It is sole responsibility of the candidate to ascertain whether they possess necessary and requisite qualification for admission to courses at SVKM's NMIMS University.
- The Basic qualification criteria for the purpose of admission to M. Pharm / M. Pharm + MBA program shall be that the candidate must have passed B. Pharm examination with 55% of marks from any Pharmacy Council of India (PCI) approved institute.
- M. Pharm / M. Pharm + MBA Programs are full-time programs
- Those candidates who are appearing for B. Pharm. examination from a recognized University where Grade Point Average is given, such candidates must produce in writing from the University concerned, the equivalent percentage for the GPA / CGPA.

4. Admission Process:

4.1 Procedure for Admission

- Admission for M. Pharm / M. Pharm + MBA is through NMIMS **Written test and Personal Interview**. (NMIMS Written test is not mandatory for GPAT Qualified candidates)
- Admission will be purely on merit basis
- The Written Test and Personal Interview shall be conducted only at Mumbai Campus and the venue will be communicated by call letter.
- Counseling shall be held at Mumbai campus / Online Mode.

4.2 Online Registration & Payment of Registration:

- Visit <u>www.nmims.edu</u> for online registration.
- Online Registration Fee of Rs. 2,500/- plus GST if applicable (Please refer online registration for payment details)
- Registration Fee is non-refundable / non-transferable.

4.3 Call Letter & Document upload:

- Candidates who are registered successfully will be called for Written Test and Personal Interview. On the basis of information indicated in the Application Form, call letter for personal interview shall be communicated to the candidate as per important dates, candidate has to check from his / her dashboard.
- Candidates are required to download the call letter from their dashboard and need to upload below mentioned documents. No separate call letter will be communicated to the candidates.

1) Copy of duly filled online application form

- 2) 10th mark sheet / passing certificate
- 3) (10+2) or equivalent mark sheet / passing certificate
- 4) Attested copies of Graduation Mark sheets & Certificate (if final year result is declared)
- 5) GPAT qualified Scores sheet if qualified
- 6) Final year (B. Pharm.) appearing candidates have to send their third-year mark sheet/s.
- Candidate's application form will not be considered if they fail to upload the above-mentioned documents till the given time-frame.
- No candidate without call letter/ admit card shall be permitted to appear for written test / personal interview.
- Candidate must carry any one requisite original ID proof for appearing for the written test / personal interview.

4.4 Selection Process:

• GPAT qualified candidates are required to upload the photocopy of GPAT score at the time of Online registration before the NMIMS Written test and personal interview, failing which the candidate shall not be considered for admission.

• Merit list shall be prepared based on the following criteria

- First M. Pharm + MBA / M.Pharm (RA) candidates shall be called for Admission Counseling as per merit list. On the day of counseling the eligible candidates shall be admitted as per merit, and vacancy. If the seats are exhausted and candidate is not able to get his / her preferred specialization, in that case candidate has to fill up preference form and give choice of specialization in preference order. It is mandatory to take admission in any of the available programmes and give preference. Same will be considered for upgradation as per availability of seat & merit in same program and in order of preference on cancellation.
- The Counseling of M.Pharm + MBA/ M.Pharm (RA) shall start simultaneously with actual numbers of seats in each specialization. If seats for particular specialization are full then preference will be taken from such candidate & upgradation will be done as per vacancy, if any.
- If any seat/s remains vacant after M.Pharm + MBA counseling then it shall be transferred to M.Pharm.
 The schedule of M.Pharm counseling shall be informed to the candidate by e-mail based on availability of seats.
- It is mandatory to participate counseling of respective programs as after counseling, candidate will not have any claim as per his / her merit. If seats remain vacant after the admissions as per merit all over, the admissions shall be as per availability of seat & first come first serve basis.

4.5 Test Structure:

- There will be Written Test and Personal Interview for M. Pharm / M. Pharm + MBA admissions.
- Duration of the Written test: 120 Minutes

4.6 Upgradation Process after counseling process:

- On cancellation, the vacant seat is offered to next eligible candidate as per merit and preference.
- Candidate has to confirm the offer in writing within time limit allotted for acceptance.
- If accepted, candidate gets transferred to that specialization. If rejected or not accepted within given time limit candidates are **not eligible** for further up gradation and remains in the same admitted specialization.
- Preference once given during counseling will not be changed later.
- Upgradation is applicable to candidate based on merit & highest preference given by candidate & vacancy.
- If a candidate has given two or more preferences during counseling & he/ she has been allotted upgradation in first preference, then his/ her other preferences shall be null and void & if he / she has been allotted in second Preference then his / her first preference will be active for further upgradation provided vacancy arise.
- 5. Program fees for batch 2025: (For Information only).
 - Program fees for 1st year M. Pharm (Batch-2024) were Rs. 3,02,000/-(For Mumbai campus) .
 - Program fees for 1st year M. Pharm + MBA (Batch-2024) were Rs. 3,80,000/-(For Mumbai campus) and Rs. 3,35,000/- (For Shirpur campus).
 - The Fees for M. Pharm / M. Pharm + MBA (Batch-2025) will be informed at the time of admission

6. Important Instructions:

- During tenure of the program changing campus shall not be permitted under any circumstances after the commencement of the program.
- For cancellation/ withdrawal of admission: Withdrawal / cancellation means voluntary withdrawal / cancellation by candidate for any reason. Candidate has to upload cancellation form duly filled and signed; fees paid receipt copy & cancelled cheque (personal account) to mentioned link: https://upload.nmims.edu/admission/cancellation/.
- Consent of parent is required for withdrawal.
- Candidate document/s will be verified at the time of admission (if selected) & if found not eligible, admission will be cancelled and fees will be refunded as per NMIMS refund policy.
- Candidates whose final mark sheet of the qualified examination is not available at the time of their provisional admission, is required to submit their final marksheet copy as soon as the result declared. In such case, if the candidate fail to meet the required eligibility criteria then his admission will be cancelled and the fees will be

refunded as per NMIMS refund rules (even after course commencement). Candidate has to check website for all details. There will be no separate communication/email sent to the candidate.

- Admission to program is considered as "Provisional Admission" till all required and mandatory documents are submitted by the candidate and the same is verified and approved. If it is found that the candidate is not eligible at any stage (even after the course commencement), admission will be cancelled and fees will be refunded as per refund rule clauses even if selected/ admitted to the program.
- Canvassing in any form will disqualify the candidate.
- NMIMS has full right to disqualify a candidate at any stage of admission process if found ineligible. No separate intimation will be given.
- It is the sole responsibility of the candidate to check whether he/ she are eligible for the respective Program as per the eligibility criteria stated above.
- All matters of dispute will be subject to the legal jurisdiction of Mumbai only.
