- 1) **Program: B. Pharm/B.Pharm+MBA (Pharma Tech) (Lateral entry to Second year)**
- 2) **Duration of the course:** 3 Years for B. Pharm and 4 years for B.Pharm+MBA (Pharma Tech)

- 3) **Eligibility Criteria & Important Instructions:** It is the sole responsibility of the candidate to check his/her eligibility before applying for the course

- Candidates passing **Diploma in Pharmacy** (Post 10+2 examination) with **minimum 60% aggregate marks** from an affiliated Institute from Pharmacy Council of India.
- Those candidates who have passed Diploma in Pharmacy program from a Board/University where Grade Point Average is given, must produce in writing from the concerned Board/University about the equivalent percentage for the GPA obtained.
- Candidate will not be considered for admission process if they fail to mention/ update the aggregate score in online registration form or their result is not available during this period.
- Submission of AIU equivalence certificate to confirm the eligibility for the program is mandatory for those candidates who have completed their examination from overseas colleges/board.
- It is the sole responsibility of the candidate to ensure that correct marks are entered.
- At the time of document verification, if it is found that the information given by the candidate regarding Diploma in Pharmacy score in online registration is incorrect / different than D. Pharm marks sheet, such candidate's admission will not be considered.
- Candidate above 25 years of age are not eligible.
- Duplicate registration will not be considered to be eligible for the programme.
- Only single mark sheet with all compulsory subjects taken and passed will be considered, no compartmentalized mark sheet shall be considered.

- Candidates whose final mark sheet of the qualified examination is not available at the time of their provisional admission, is required to submit their final marksheet copy as soon as the result declared. In such case, if the candidate fail to meet the required eligibility criteria then his/her admission will be cancelled and the fees will be refunded as per NMIMS refund rules (even after course commencement).
- The X / XII / Diploma (Qualified) examination should have been conducted before the course commencement date.
- Internal Program / campus Transfer will be not entertained at any reason.
- It is sole responsibility of the candidate to ascertain whether they possess necessary and requisite qualification for admission to courses at NMIMS University.
- The candidate must have appeared for all his subject(s) / exams before the commencement of the respective program (s) of NMIMS (Deemed to be University). The examination of none of the subjects should be held after the commencement of the respective course. If selected, provisional admission will be given subject to clearing the final examination. Fees will be accepted from such candidates but their admission will be confirmed on the submission of final mark sheet on or before 30th September'2026. The candidate's admission will be revoked, if they fail to present the mandatory document as specified
- If a candidate is found ineligible even after commencement of the program, he / she would be discontinued from the program and fees will be paid in accordance with standard procedure.

5.1 Online Registration:

- a) Online Registration Fee of Rs. 2,000/- plus GST if applicable (Please refer online registration for payment details)
- b) Registration Fee is **NON-REFUNDABLE / NON-TRANSFERABLE**.
- c) Candidate has to provide two preferences compulsory from available options in the registration form.

5.2 Selection Process:

- It is mandatory to fill up all details including D. Pharm aggregate final score.
- For selection, candidate list will be prepared based on aggregate percentage of marks secured by the candidate in Diploma in Pharmacy.
- The decision of the institute will be final in this regard and no enquiries or correspondence in this regard will be entertained.
- If two or more candidates secure same aggregate percentage of marks in Diploma in Pharmacy, then their relative merit will be decided as per candidate securing higher aggregate percentage in 12th examination.
- Campus preferences once given in online registration will not be changed later.
- Candidates will be given admission to the program as per their merit, vacancy & availability of campus preference.
- The merit list will be put up on the NMIMS website as per important dates. The decision of the institute will be final in this regard and no inquiries or correspondence in this regard will be entertained.

5) Program Fees: (Subject to change)

Program fees for 2nd year B. Pharm (lateral entry) - (Batch-2025) was Rs. 3,00,000/- (For Mumbai campus) and Rs. 1,40,000/- (For Shirpur campus, Hyderabad). Rs.175000/- Indore campus

Program fees for 2nd year B.Pharm+MBA (Pharma Tech) (lateral entry) - (Batch-2025) was Rs. 3,00,000/- (For Mumbai campus) and Rs.4,75,000/- Shirpur campus, Rs. 2,02,000/- Hyderabad).

Fees for current year i.e 2026 will be intimated at the time of admission.

6) REFUND OF FEES IN CASE OF WITHDRAWAL / CANCELLATION OF ADMISSION:

For cancellation/ withdrawal of admission: Withdrawal /cancellation means voluntary withdrawal/cancellation by a candidate for any reason. Please visit the NMIMS website for the online admission cancellation process: <https://upload.nmims.edu/admission/cancellation/>
Refund rules from competent authorities will be followed.

Note:

Please note the closure of admission / last date of admission as mentioned in the important dates of

the respective program.

The Candidate is requested to check the commencement date. The cancellation policy/date is applicable as the refund rule clause mentions.

7) **Important instructions**

- Candidates will be offered Campus based on the availability of seat, candidates merit rank, preferences given at the time of online registration.
- Change of campus will be considered as per preference, merit rank and availability of seat after the subsequent merit list and if admission granted to particular branch/campus till course commencement only.
- During tenure of the program changing campus shall not be permitted under any circumstances after the commencement of the program at a particular branch / campus.
- Please see the important dates and preserve it as a guide. All announcements from the institute will be through its web site: www.nmims.edu and no individual communication will be sent to the candidates.
- Admission to program is considered as “**Provisional Admission**” till all required and mandatory documents are submitted by the candidate and the same is verified and approved. If it is found that the candidate is not eligible at any stage (even after the course commencement), admission will be cancelled and fees will be refunded as per refund rule clauses even if selected/ admitted to the program.
- All matters of dispute will be subject to the legal jurisdiction of Mumbai only.
- It is the sole responsibility of the candidate to check whether he/ she is eligible for the respective Program as per the eligibility criteria stated above.
- NMIMS has full right to disqualify a candidate at any stage of admission process if found ineligible. No separate intimation will be given
- Canvassing in any form for admission will disqualify the candidate.
- The admission information handout's eligibility requirements will serve as the only document for program eligibility. School's brochure or prospectus or any other promotional material will only be used as a guide and not be used to refer eligibility.
- The payment of fees does not confirm fulfilment of the admission eligibility criteria. Admission will be granted only after verification of all required documents and compliance with the prescribed eligibility norms.
