<u>Refund Rules</u>: If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution concerned shall follow the following five-tier system for the refund of fees remitted by the student.

(1)	100%	15 days or more before the formally-notified last date of admission (on or before 28 th August'2021)
(2)	90%	Less than 15 days before the formally-notified last date of admission. (29 th August to 13 th September 2021)
(3)	80%	15 days or less after the formally notified last date of admission. (14 th September to 28 th September 2021)
(4)	50%	30 days or less, but more than 15 days, after formally notified last date of admission. (29th September to 13th October 2021)
(5)	00%	More than 30 days after formally notified last date of admission. (14 th October'2021 onwards)

In case of (1) in the table above, the HEI concerned shall deduct an amount not more than 5% of the fees paid by the student, subject to a maximum of Rs. 5,000/- as processing charges from the refundable amount.
