Refund Rules:

If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution concerned shall follow the following five-tier system for the refund of fees remitted by the student.

Sr. No.	Percentage of Refund of Aggregate fees*	Point of time when notice of withdrawal of admission is served to HEI
(1)	100%	15 days or more before the formally-notified last date of admission (on or before 01st July'2020)
(2)	90%	Less than 15 days before the formally-notified last date of admission. (02nd July to 17th July'2020)
(3)	80%	15 days or less after the formally-notified last date of admission. (18th July to 01st August'2020)
(4)	50%	30 days or less, but more than 15days, after formally-notified last date of admission. (02nd August to 16th August'2020)
(5)	00%	More than 30 days after formally-notified last date of admission. (17th August'2020 onwards)

In case of (1) in the table above, the HEI concerned shall deduct an amount not more than 5% of the fees paid by the student, subject to a maximum of Rs. 5,000/- as processing charges from the refundable amount.

Note: Candidates to refer Important Dates of the respective programme.

The above refund rules are as per University Grants Commission (UGC) notification on Refund of Fees and Non Retention of Original Certificates of October, 2018 and are subject to revision as per UGC notification (as applicable).
