**<u>Refund Rules</u>**: If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution concerned shall follow the following five-tier system for the refund of fees remitted by the student.

Sr. No.	Percentage of Refund of Aggregate fees*	Point of time when notice of withdrawal of admission is served to HEI
(1)	100%	15 days or more <b>before</b> the formally-notified last date of admission. (on & before 02 <sup>nd</sup> September 2020)
(2)	90%	Less than 15 days <b>before</b> the formally-notified last date of admission. (3 <sup>rd</sup> September to 18 <sup>th</sup> September'2020)
 (3)	80%	15 days or less <b>after</b> the formally notified last date of admission. (19 <sup>th</sup> September to 3 <sup>rd</sup> October'2020)
(4)	50%	30 days or less, but more than 15 days, <b>after</b> formally notified last of admission <b>(4<sup>th</sup> October to 18<sup>th</sup> October'2020)</b>
(5)	00%	More than 30 days <b>after</b> formally notified last date of admission. (19 <sup>th</sup> October'2020 onwards)

In case of (1) in the table above, the HEI concerned shall deduct an amount not more than 5% of the fees paid by the student, subject to a maximum of Rs. 5,000/- as processing charges from the refundable amount.
