(1)	100%	15 days or more before the formally-notified last date of admission. (on & before 15 th July'2020)
(2)	90%	Less than 15 days before the formally-notified last date of admission. (16 th July to 31 st July'2020)
(3)	80%	15 days or less after the formally notified last date of admission. (01st August to 15th August'2020)
(4)	50%	30 days or less, but more than 15 days, after formally notified last of admission (16 th August to 30 th August'2020)
(5)	00%	More than 30 days after formally notified last date of admission. (31st August'2020 onwards)

In case of (1) in the table above, the deduction will be 5% of the fees paid as processing charges from the refundable amount, subject to a maximum of Rs 5,000/-.
