**Refund Rules:**

If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution concerned shall follow the following five-tier system for the refund of fees remitted by the student.

Sr. No.	Percentage of Refund of Aggregate fees*	Point of time when notice of withdrawal of admission is served to HEI
(1)	100%	15 days before the formally-notified last date of admission <b>(on or before 17<sup>th</sup> Aug 2019 )</b>
(2)	90%	Less than 15 days before the formally-notified last date of admission. <b>(18<sup>th</sup> August to 02<sup>nd</sup> September 2019 )</b>
(3)	80%	Not more than 15 days after the formally-notified last date of admission. <b>(03<sup>rd</sup> September to 17<sup>th</sup> September 2019 )</b>
(4)	50%	More than 15 days but less than 30 days after formally-notified last date of admission. <b>(18<sup>th</sup> September to 3<sup>rd</sup> October 2019 )</b>
(5)	00%	More than 30 days after formally-notified last date of admission. <b>( 4<sup>th</sup> October onwards)</b>

In case of (1) in the table above, the HEI concerned shall deduct an amount not more than 5% of the fees paid by the student, subject to a maximum of Rs. 5,000/- as processing charges from the refundable amount.

The above refund rules are as per University Grants Commission (UGC) notification on Refund of Fees and Non Retention of Original Certificates of October, 2018 and are subject to revision as per UGC notification (as applicable).
